# PURPOSE:

For Council to approve the 2024 Joint Funding and Joint Budget Amounts as agreed to at the meetings with the MD.

#### **RECOMMENDATION:**

That Council for the Town of Pincher Creek approve the 2024 Joint Budget amount at 50% with the Municipal District of Pincher Creek, the Town's portion is \$219,127.50;

# BACKGROUND/HISTORY:

On September 6, 2023, the Joint Funding Committee, comprised of Councilors from the Town of Pincher Creek and the Municipal District of Pincher Creek, met to discuss Joint Funding for 2024.

For 2024 Joint Funding there were 33 separate applications submitted, with a total funding request of \$439,330.00. After careful deliberation, 15 applications were approved. The total Joint Funding contribution will be \$133,000 for 2024. The Town of Pincher Creek's share will be \$70,201.98 based on a population of 3,622.

On September 19, 2023, Councilors from the Town of Pincher Creek and the Municipal District of Pincher Creek, met to discuss Joint Budgets for 2024. Council met with the 6 organizations to discuss their budget requests. Councils agreed to fund the 6 organizations in the amount of \$438,255.00 with the Town's share being 50% or \$219,127.50.

# **PURPOSE:**

For Council to approve a 2023 budget adjustment to enable administration to hire a consultant to assist with meeting the Public Sector Accounting Board (PSAB) 3280 requirement of recognizing the Town's Asset Retirement Obligation in the 2023 financial statements.

# **RECOMMENDATION:**

That Council for the Town of Pincher Creek approve a 2023 budget adjustment of \$49,484 to engage a consultant to assist administration in meeting the PSAB 3280 requirement of recognizing the Town of Pincher Creek's Asset Retirement Obligation in the 2023 audited financial statements; and further that this amount be funded from the Municipal Income Stabilization Reserve if required.

# BACKGROUND/HISTORY:

The Public Sector Accounting Board (PSAB) was created to serve the public interest by establishing accounting standards for the public sector. For example, the requirement to start recording tangible capital assets in 2009 was a project initiated and implemented by this Board. PSAB is now requiring municipalities to record as a liability an asset retirement obligation.

Municipalities will now be required to determine what activities they perform that creates the obligation and record the obligation when that activity occurs.

An asset retirement obligation (ARO) is a legal obligation associated with the retirement of a tangible capital asset. Examples of assets that have a retirement obligation would be municipal buildings that contain asbestos. When a municipality wants to demolish a building with asbestos, provincial regulation requires it to be removed in a prescribed manner which will result in added expense to the municipality.

As with the Tangible Capital Asset Project, to record ARO for current Tangible Capital Assets requires more work and expertise then the Town has at its disposal at the present time. Therefore, Administration needs to hire consultants with the expertise and time to prepare this for the 2023 audited financial statements.

#### ALTERNATIVES:

That Council for the Town of Pincher Creek request further information from Administration to be presented at a future Council meeting.

#### **IMPLICATIONS/SUPPORT OF PAST STUDIES OR PLANS:**

The MGA requires municipalities to have their financial statements audited annually. If the Town does not follow the requirements as set out in PSAB 3280, the auditor may qualify their audit opinion.

#### FINANCIAL IMPLICATIONS:

The quote received for the consultant is \$49,484 to be funded from the Municipal Stabilization Reserve if required.
