#### **PURPOSE:**

Reporting to Council a reallocation of budget dollars

#### **RECOMMENDATION:**

That Council for the Town of Pincher Creek accept the report as presented.

#### **BACKGROUND/HISTORY:**

As per Policy 106-13 AP, Cheque Issue, Expenditure Section 4.9, "The CAO may reallocate budget dollars within the capital budget and the operating budget." Section 4.9.1 "Reallocations in excess of \$5,000 are to be reported to Council."

Due to the pandemic, training and travel for the last two years has been lower than budget. During 2022 budget deliberations, administration suggested reducing the training and travel allocations with the expectation that many courses would still be offered online resulting in less cost. Training and Travel in some cost centres will exceed budget this year due to new staff requiring training and training and conferences being in person. The expenditure for Human Resource Services is expected to be lower than budget this year. The CAO will be reallocating \$12,000 from Professional Services to Training and Travel to cover additional training for the Community Peace Officers, Water Treatment Plant Operator, New Asset Management Coordinator, and the conferences for Communities in Bloom and Southern Alberta Recreation Association.
