**A BYLAW TO AUTHORIZE THE RATES OF TAXATION TO BE LEVIED AGAINST ASSESSABLE PROPERTY WITHIN THE TOWN OF PINCHER CREEK FOR THE 2026 TAXATION YEAR**

WHEREAS, the Town of Pincher Creek has prepared and adopted detailed estimates of municipal revenue, expenses and expenditures as required, at the Council meeting held on December 9, 2024 and budget adjustments March 24, 2025 and April 27, 2026;

**WHEREAS**, the estimated 2026 municipal revenues from all sources other than property taxation total **\$6,491,244** and:

**WHEREAS**, the estimated municipal expenses (excluding non-cash items) set out in the annual budget for the Town of Pincher Creek for 2026 total **11,677,281**; and the balance of **5,186,037** is to be raised by general municipal property taxation

**WHEREAS**, the estimated amount required to repay principal debt to be raised by general municipal taxation is **243,669** and;

**WHEREAS**, the estimated amount required for current year capital expenditures to be raised by general municipal taxation is **NIL** and;

**WHEREAS**, the estimated amount required from future financial plans to be raised by municipal taxation is **1,314,905** and

**WHEREAS**, the estimated amount transferred from reserves is **1,080,718** and

**THEREFORE** the total amount to be raised by general municipal taxation is **5,663,893** and

WHEREAS, the requisitions are:

WHEREAS, the Council of the Town of Pincher Creek is authorized to classify assessed property, and to establish different rates of taxation in respect to each class of property, subject to the Municipal Government Act, Chapter M-26, Revised Status of Alberta; 2000, and

WHEREAS, the assessed value of all property in the Town of Pincher Creek as shown on the assessment roll is:

Residential and Farmland	543,515,770
Non-Residential	<u>171,300,290</u>
 Total Assessment	 <u>714,816,060</u>

NOW THEREFORE, under the authority of the *Municipal Government Act*, the Council of the Town of Pincher Creek, in the Province of Alberta, enacts as follows:

1. That the Chief Administrative Officer is hereby authorized to levy the following rates of taxation on the assessed value of all property as shown on the assessment roll of the Town of Pincher Creek:


