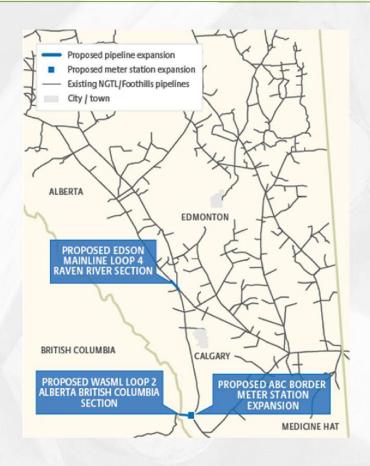

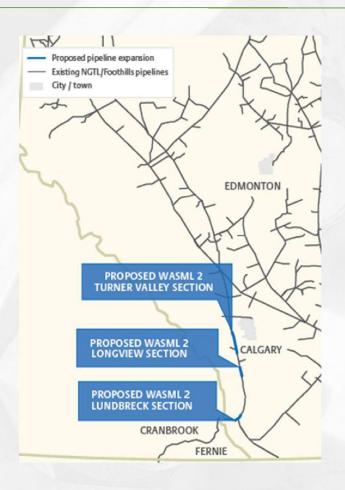

Socio-Economic Assessments

NGTL conducted a socio-economic assessment (SEA) to consider potential effects of the Projects on nearby communities.

In particular, we looked at topics including:

- Interactions of construction workforce in nearby communities
- Changes in demand for community infrastructure and services (accommodations, emergency services, health care)
- Increased traffic volumes as a result of transporting workers and equipment
- Effects of construction activities such as noise, lights or access restrictions on any nearby residents or land users
- Increased economic benefits (contract procurement and employment opportunities)

The Projects will not create significant adverse socio-economic effects given the negligible to low scale of construction and operations activities.

PURPOSE:

To advise Council of the financial status of the P.C. Golf Club as of June 30, 2020

RECOMMENDATION:

That Council for the Town of Pincher Creek receive the financial update for the Pincher Creek Golf Club as presented.

BACKGROUND/HISTORY:

At the May 25, 2020 Council meeting, council discussed the anticipated financial needs of the Pincher Creek Golf Club to maintain the course during the COVID Pandemic shutdown with no revenue coming in. After reviewing the minimum maintenance costs as shared with the CAO, Council made the resolution to provide up to \$15,430 for the first two months of operation, any further requests would be brought back to Council. The CAO was directed to work with the club in this regard.

The Golf Club executive provided the financial documents for May and June which show a much more positive statement than had previously been anticipated. With the new circumstances being considered, the CAO and Finance Officer met with two members of the golf executive on Tuesday, July 14th, where the club was advised that they would not be receiving the approved funding at this time. The club agreed and explained that they have been experiencing a large increase in users, particularly walk ins (green fees).

The CAO advised that they should continue to provide monthly financial updates to the Town, if the financial status changes for the worst, we could ask Council to consider the proposed funding supplement at that time.

The club also asked if Council would consider putting the proposed funding support of up to \$30,860 into a reserve for 2021 equipment needs. (mower).

In addition, the club asked about the potential for a municipal discount on equipment and were advised to talk to their equipment dealer to see if this is something they offer, and that the Town would be willing to participate.

ALTERNATIVES:

That Council for the Town of Pincher Creek designate \$30,860 into an equipment reserve for the 2021 golf season, to be used for the purchase of a new mower.

That Council for the Town of Pincher Creek direct administration to hold the proposed supplement of \$30,860 in reserve for a future shortfall in golf course funding operations.

IMPLICATIONS/SUPPORT OF PAST STUDIES OR PLANS:

Golf Course past identification of irrigation replacement needs.

FINANCIAL IMPLICATIONS:

Proposed funding supplement of \$30,860 not presently required due to increased golf course revenue.

PUBLIC RELATIONS IMPLICATIONS:

Working with volunteer organizations to continue services within the community as required.

PURPOSE:

For Council to discuss the options available to fund the remaining \$2,000,000 needed for the Pincher Creek Early Learning Centres.

RECOMMENDATION:

That Council for the Town of Pincher Creek direct administration to proceed as directed at the September 4, 2019 Regular Meeting of Council.

BACKGROUND/HISTORY:

- 1. At the Regular Council Meeting on August 7, 2019, Council adjusted the budget for the new early learning centres indicating that they would be funded using \$2 Million of reserves and borrow \$2 Million.
- 2. Town of Pincher Creek has utilized \$2,000,000 of reserves to fund the construction of the two new early learning centres as directed by Council at the September 4, 2019 Regular Council Meeting.
- 3. At the September 4, 2019 Regular Council Meeting, Council directed administration to pursue \$2,000,000 of financing through CIBC for a term of 15 years.
- 4. Currently, the Town of Pincher Creek has accessed a \$2,000,000 line of credit through CIBC with the intention of converting it to a loan as directed at the September 4, 2019 Regular Council Meeting.
- 5. Due to the recent economic events resulting from Covid-19 and the Municipal District of Pincher Creek No.9 commitment of \$1,000,000 to the construction, administration thought it prudent to discuss with Council various financing options.
- 6. The BA Swap rates are lower than when CIBC made their presentation to Council due to recent financial events. Attached is a summary of the financing options available for two different loan types and two different terms.
- 7. The minimum amount the Town may borrow through a BA Swap is \$2,000,000.
- 8. At the May 11, 2020 Regular Council Meeting, Council decided to use Municipal Initiative funding for the early learning centres as required.
- 9. The Town of Pincher Creek has been awarded new funding of \$2,555,000 from the Provincial Government for a new Sanitary Force Main Line from the wastewater lagoons. This is 52.27 percent funding so the Town must contribute approximately \$2,333,000 towards the project to be eligible for the full grant. Council will need to decide how to fund this project as well.

IMPLICATIONS/SUPPORT OF PAST STUDIES OR PLANS:

During the Strategic Planning Process in January 2018, Council indicated that constructing two early learning child care facilities would be a success factor.

FINANCIAL IMPLICATIONS:

As of 2020, increasing property taxes by 1% results in \$43,798.91.

The required increase in property taxes to cover the \$2,000,000 will range between 2.10% and 3.86%. An additional increase in taxes may be required to cover operating expenditures given that the MSI Operating Grant for the Town has been reduced by 2/3. Council may also want to consider replacing the \$2,000,000 of reserves through an increase in property taxes.

If the Town or PCCELC realizes surpluses, those may be used to cover the loan payments.

PUBLIC RELATIONS IMPLICATIONS:

There was no public opposition to the Borrowing Bylaws for construction of the two new early learning centres when they were advertised in 2019.

FINANCING ALTERNATIVES – PINCHER CREEK COMMUNITY EARLY LEARNING CENTRE

FINANCING OPTIONS:

- Option 1: Replenish the Town of Pincher Creek's reserves with the \$1,000,000 from the Municipal District of Pincher Creek No. 9 commitment as the funds are received. Finance the remaining approximately \$2,000,000 through a Banker's Acceptance (BA) Swap with CIBC. Given the very low interest rates 1.84% for 15 years and 2.27% for 30 years, it is an excellent time to borrow. Loan payments could be made through future Town surpluses if there is any, or the reserve established from the MD of PC payments, or PCCELC operations if they realize surpluses etc.
- Option 2: Finance the remaining approximately \$2,000,000 through a BA Swap through CIBC including the lump sum payments committed by the MD of PC over the next five years. The dates of payment will need to be discussed and agreed to in order to include them as payments in the BA Swap. Council will have to decide how to finance the remaining \$1,000,000, could be through future MSI payments, property tax levies, interest earned on reserves etc.

 Currently interest earned on reserves is allocated as follows: the first \$113,000 New Arena Reserve and the remainder which can be \$137,000 Equipment Reserve. Since reducing the reserves for this project, this interest may be lower in future years.

•

FINANCING ALTERNATIVES – PINCHER CREEK COMMUNITY EARLY LEARNING CENTRE

- Option 3: Leave the \$2,000,000 on a floating rate loan (currently CIBC Prime Rate less 0.50% = 1.95%). Pay the loan with MSI Grant funding of approximately \$500,000 for 2020 and the MD of PC first payment of \$500,000 once received in the fourth quarter of 2020. Continue paying the loan each year with the MD of PC commitment of \$100,000 each year for the next 5 years. Council will have to decide how to pay the remaining \$500,000 plus interest alternatives listed above.
- Option 4: Pay the line of credit in full in 2020 using MSI Grant funding of \$500,000, MD of PC \$500,000 and the remainder \$1,000,000 plus interest through additional Town of Pincher Creek Reserves. Replenish the reserves with the MD of PC \$100,000 payments over the next five years. If this option is chosen, Council must decide which Town reserves to reallocate to this project.

PURPOSE:

To request additional funds/change of scope in the capital budget for required watermain repair due to multiple watermain breaks and increasing risk of waterline rupture which would dramatically impact the Low Pressure Zone of the water distribution system (including the downtown core).

RECOMMENDATION:

That Council for the Town of Pincher Creek approve \$150,000 for replacement of the Low Pressure Zone water distribution main located at the Old Water Treatment Plant and cancel the previously approved \$125,000 Pressure Reducing Valve project from the 2020 Capital Budget.

BACKGROUND/HISTORY:

The Town's Water Treatment Plant utilizes two (2) major distribution watermains to feed the Town's water network, divided into high and low pressure zones (see attached diagram):

- High Pressure Zone provides 2/3 of Town's water supply to the north and south areas of Town
- Low Pressure Zone provides 1/3 of Town's water supply to central and east areas of Town including the downtown core

The water distribution main which feeds the Low Pressure Zone runs through the basement of the Old Water Treatment Plant, located on Main Street/Canyon Drive.

In August 2019 a major leak was detected in the watermain within the Old Water Treatment Plant. A welder was hired to make emergency repairs to the pipe.

During 2020 budget discussions \$200,000 was requested for the Old Water Treatment Plant which would have been used for repairs including replacement of this watermain but was ultimately deferred until 2021 in hopes no major issues arose.

In June 2020 another major leak was detected on the same section of pipe and again a welder was hired for emergency repairs. Operations reassessed the integrity of the pipe wall determining it to be very thin and was in a very vulnerable state.

The state of the steel pipe within the Old Water Treatment Plant is rapidly corroding and is at high risk of a major break which could potentially disrupt water distribution to the downtown core.

The proposed solution is to abandon the existing watermain within the basement of the Old Water Treatment Plant and re-route the watermain on the outside of the building.

As part of the planning for this repair, it was determined that the originally budgeted Pressure Reducing Valve to be located on Bev McLachlin Drive should be deferred until after updated water modelling is completed as part of the Infrastructure Master Plan Update. Operations therefore recommends this project be cancelled and brought forward for future consideration during the budget cycle.

ALTERNATIVES:

that Council for the Town of Pincher Creek defer the Low Pressure Zone watermain replacement project for consideration in the 2021 budget.

IMPLICATIONS/SUPPORT OF PAST STUDIES OR PLANS:

The major distribution watermains are considered high-consequence assets with higher risk of impacting service.

FINANCIAL IMPLICATIONS:

Cancel Bev McLachlin PRV project for -\$125,000. Approve Low Pressure Zone Watermain Replacement for +\$150,000.

Net increase of +\$25,000 to capital budget for G/L 4100006616

PUBLIC RELATIONS IMPLICATIONS:

In the event of a major pipe rupture at the Old Water Treatment Plant there is potential to lose water pressure to the central/downtown area within the Low Pressure Zone causing disruption to water service.

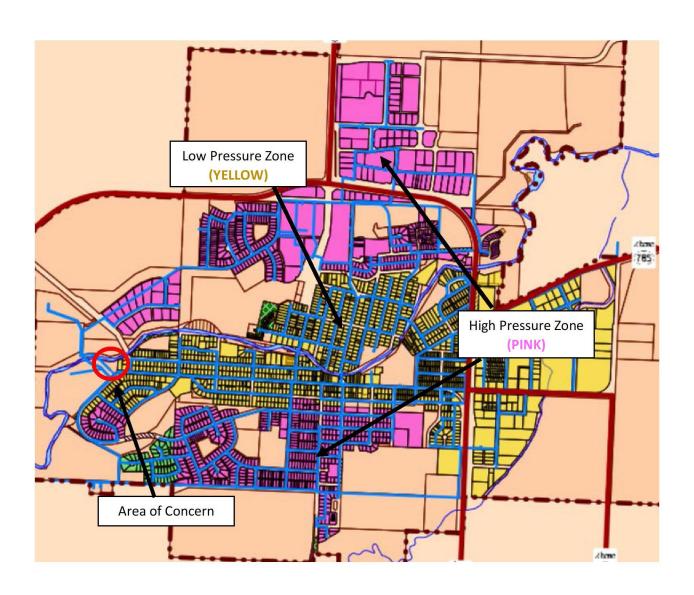

PURPOSE:

For Council to consider a request to have mural maintenance and repair completed in 2020.

RECOMMENDATION:

That Council for the Town of Pincher Creek allocate up to \$10,000 in the 2020 budget for mural repair with the funds from the Parks Reserve #_____.

BACKGROUND/HISTORY:

The Communities in Bloom Committee and the Town of Pincher Creek have been involved in the creation several murals across town. There are currently 5 murals in town, of which 1 is in dire need of immediate major repairs, and a second one will be needing repairs in the very near future.

There was \$3,500 set aside for mural repair in the 2019 budget, and it was anticipated town staff could complete these repairs, however, due to time constraints these repairs were not completed fully in 2019.

The cattle drive mural located at 1034 Beverly McLachlin Drive was completed approximately 20 years ago and experienced significant water damage and some minor repairs were completed in 2010. The water issue has been remedied, however, there is still significant paint peeling at this location. The painting needs to be fixed in some major areas, and a sealant will need to be applied to protect the mural moving forward. The second mural needing repair is the one located at the corner of Hewetson and Main Street. The bottom portion of this mural was repaired by town staff, but the top section which requires a lift and additional time still needs to be completed.

There is currently \$5,000 set aside in the 2022 operating budget for mural repair.

ALTERNATIVES:

Get some quotes to have the mural completely redone for the cattle drive mural located at 1034 Beverly McLachlin Drive.

Add these projects to the 2021 budget discussions.

Advise the Communities in Bloom Committee to apply for Joint funding for this project. - it should be noted the cattle drive mural is deteriorating rapidly and requires immediate attention.

IMPLICATIONS/SUPPORT OF PAST STUDIES OR PLANS:

None

FINANCIAL IMPLICATIONS:

Communities in Bloom is currently in the process of applying for some grant funding to have this project completed, however, some of these grants are based on matching dollars.

The Communities in Bloom committee has a small amount of funding available in their mural fund, however, it will not cover the anticipated cost for repair.

A quote for labour has been received to repair the Cattle Drive Mural for a total cost of \$3,600, this does not include the cost of a lift or materials. The lift rental is \$1000, and paint and supplies are estimated at \$1000. The mural located at Hewetson and Main Street is much larger and would require significantly more time and supplies.

PUBLIC RELATIONS IMPLICATIONS:

Pincher Creek well known for it's downtown mural program, and it adds to the beautification of the downtown core.

PURPOSE:

To adust 2019 reserve transfers to actual.

RECOMMENDATION:

That Council for the Town of Pincher Creek approve the additional reserve transfers for 2019 as per attached and that a copy be attached hereto and form part of the minutes.

BACKGROUND/HISTORY:

The accessories for the bylaw truck, the snow gate for the grader and the upgrades to the east avenue sanitary line cost more than anticipated. The bobcat excavator and bobcat loader are on a frequent trade in program so the net trade in cost of the two machines of \$12,915 was expensed through the operating budget. However, the full value of these two items should be capitalized resulting in a transfer from reserves. At year end the value of these capital assets are then transferred to the Capital Equity.

The Water Distribution Upgrade projects was identified in the first 4 year Capital Budget prepared in the fall of 2014 for 2015 to 2018. Each year identified a different area to be upgraded using MSI capital funding and reserves if necessary for an estimated annual project cost of \$300,000. The area between Dundas St. and Adelaide St. along Morden Avenue and Albert Avenue was one of those areas included in the 4 year capital budget.

In February 2015, the Small Communities Fund Grant was announced indicating projects had to be applied for by April 2, 2015. Administration went back to Council on March 23, 2015 to request the projects already identified in the 4 year capital budget be increased to take full advantage of the grant as per motion #15-103 attached.

The Water Distribution Upgrade project was tendered in 2018 for Thistle Crescent, Morden and Albert Avenue and fire hydrant replacements. The total cost for Morden and Albert Avenue was \$917,880. Administration decided to remove Morden for 2018 and include it in the 2019 budget resulting in a total cost for the whole tender of \$892,056 which was within the 2018 budget amounts as per attached council motion #18-403.

During the 2018 construction season, the Thistle Crescent and the Crestview waterline became priorities, resulting in a delay of the Albert Avenue project. In the fall of 2018,

during the budget process the amount for the Albert Avenue project should have been carried forward and included with the amount for Morden Avenue but it was missed.

ALTERNATIVES:

That Council for the Town of Pincher Creek request administration provide more information at a future meeting.

IMPLICATIONS/SUPPORT OF PAST STUDIES OR PLANS:

During the strategic planning process, Council identified enhanced community infrastructure as one of their priorities.

FINANCIAL IMPLICATIONS:

The total reserve transfer is \$690,676 as per attached spreadsheet.
