#### **PURPOSE:**

Stacey McRae with the Allied Arts Council attended the September 24, 2020 Council Meeting to discuss reallocating municipal funds from the Lebel Mansion Elevator Project to replacing the Lebel Mansion Veranda.

#### **RECOMMENDATION:**

That Council for the Town of Pincher Creek defer the Lebel Mansion Veranda to the 2021 Budget Discussions.

#### BACKGROUND/HISTORY:

As presented by Stacey McRae with the Allied Arts Council, the Lebel Mansion Veranda's condition is rapidly disintegrating and creating a safety hazard for residents. It was requested that this veranda be replaced.

In late 2019, Council approved \$170,000 for the installation of an elevator at the Lebel Mansion anticipating approximately \$70,000 to be funded through a grant received by Allied Arts and the remaining \$100,000 be funding through municipal funding. In summer 2020 Allied Arts received confirmation they received an additional \$100,000 grant for the elevator, reducing the municipal contribution by the same amount.

Allied Arts requested that the municipal funds that were no longer required for the elevator project be reallocated to the veranda replacement.

Operations had requested Capital Funding for the Veranda Rep<mark>lac</mark>ement in 2019 but was denied. It was requested to be carried forward but was not allocated to any specific year.

Operations has requested \$100,000 in the 2021 Capital Budget for the replacement of the Lebel Mansion Veranda.

#### **ALTERNATIVES:**

That Council for the Town of Pincher Creek approved \$100,000 from the Municipal Income Stabilization Reserve.

That Council for the Town of Pincher Creek accept the Lebel Mansion Veranda funding request as information.

#### **IMPLICATIONS/SUPPORT OF PAST STUDIES OR PLANS:**

None at this time.

#### FINANCIAL IMPLICATIONS:

To be discussed during 2021 Budget Discussions. Project anticipated to be \$100,000 with both Pincher Creek and Allied Arts investigating grants opportunities.

The Lebel Mansion is utilized by many community members and organizations including Allied Arts and various small businesses operating out of the Lebel Mansion. The veranda is the main entrance to the facility and therefore impacts all users.





#### **PURPOSE:**

To consider the request to waive interest on tax roll account numbers 01135000.0000 and 01070000.0000.

#### **RECOMMENDATION:**

That Council for the Town of Pincher Creek accept the email received July 27, 2020 regarding property tax account for roll 01135000.0000 and 01070000.0000 as information and direct administration to respond accordingly.

#### **BACKGROUND/HISTORY:**

The assessor reviews all Town of Pincher Creek properties over a 5 year cycle. The commercial/industrial area where this property owner is located was evaluated in 2019. The assessor determined that a number of properties in this area had previously been assessed using the income method and were not meeting the equity and market standards. Therefore, the assessor moved the majority of this area (hotels/motels notwithstanding) back to a cost based method of valuation which uses the depreciated replacement cost of the buildings coupled with the value of the land and then factored to market through the market analysis process. This change increased the assessment for this property owner by \$200,290.00 and \$5,200.

The assessor received an inquiry from the property owner at which time they had a discussion about the assessment process and the reason for the changes.

They also discussed the recent purchase of the property which was significantly higher than the new assessment, almost \$500,000. The assessor explained that the sale was not the reason for the assessment change but in the end it was a good supporting indicator of value for this property.

The assessor did agree to phase in the increase which is not a requirement of the assessment process.

Payment of taxes is not dependent on the assessment appeal process as indicated in the attached 2020 tax enclosure "Understanding Your Property Assessment 2020" which states "An assessment appeal DOES NOT exempt you from paying taxes on time or from late payment penalties."

#### **ALTERNATIVES:**

That Council for the Town of Pincher Creek agree to waive the penalty applied to tax roll account number 01135000.0000 for \$241.82 and tax roll account number 01070000.0000. for \$1,284.04 as per section 347(1) of the MGA.

That Council for the Town of Pincher Creek request more information from Administration.

#### **IMPLICATIONS/SUPPORT OF PAST STUDIES OR PLANS:**

The Council for the Town of Pincher Creek has received these requests in the past and have denied them.

#### **FINANCIAL IMPLICATIONS:**

There is no financial implications if Council agrees to uphold the bylaw and not reverse the penalties. If Council recommends reversing the penalties, the total financial implication would be \$1,525.86.

#### Dear Property Owner

The Town of Pincher Creek mails the combined assessment and tax notices late in April with the property tax payment deadline being June 30 or the first business day after June 30 if June 30 falls on a non-business day for the Town of Pincher Creek. Once the notices have been mailed, the Town advertises that the notices have been sent. As per the Municipal Government Act Revised Statutes of Alberta 2000 Chapter M-26 (MGA) section 311 (2), all assessed persons are deemed, as a result of the advertisement, to have received their assessment notices; and as per section 337, a tax notice is deemed to have been received 7 days after it is sent.

Administration for the Town of Pincher Creek works diligently to ensure all combined assessment and property tax notices are mailed to the appropriate property owner. If a property owner has not received their notice, they are obligated to contact the Town to obtain a copy. Property owners require a copy of the combined assessment and tax notice as it provides important information for the property owner to appeal their property assessment if they so choose, as well as information concerning the deadline to pay the property taxes without incurring a penalty.

As per Bylaw No. 1395-19 Penalty on Unpaid Current Taxes and Unpaid Arrears Taxes, a 12% penalty is levied on the next business day following the due date printed on the property tax notice for any current unpaid taxes and an additional 10% of the total taxes unpaid on December 31 is levied on January 1. If December 31 falls on a non-business day for the Town of Pincher Creek, the 10% penalty is added on the second business day after December 31. The property tax deadline and the numerous methods residents may use to settle their account are extensively advertised through newspaper, radio, social media, newsletter and the Town website to name a few. These advertisements indicate that payments can be made by mail, online banking or at any financial institution, also in person by attending the Town office during business hours and/or leaving payments in the mail slot. As well, property owners can pay their property taxes monthly through the Tax Installment Payment Plan (TIPP). This option reduces the risk of missing the property tax deadline due to human error. If this option is of interest to you, please come to the Town Office and enroll.

Although you are faced with an unfortunate situation, Council has consistently upheld Bylaw No. 1395-19 Penalty on Unpaid Current Taxes and Unpaid Arrears Taxes and has not forgiven penalties imposed. Since 2014, property taxes in the Town of Pincher Creek have been due on June 30 with extensive advertising of the deadline and the numerous ways the amount may be paid during business hours or after hours. Council agrees that it would be unfair to residents that ensure their property taxes are paid on time to forgive penalties.

Trusting this information to be satisfactory.

### What can I do if I disagree with the Assessors estimate of my property value?

Prior to filing a written complaint, you are encouraged to fill out the assessor's inquiry form at http://www.kcl-consulting.com/inquiry-form/or contact the Town of Pincher Creek at phone number 403-627-3156 to request that the designated Assessor Review your property assessment. If the Assessor determines that an error has been made, your assessment will be revised.

### I still disagree with the assessment or tax classification. What should I do?

You may appeal your assessment by filing a formal complaint to be heard by the Local Assessment Review Board (residential property with 3 or less dwelling units, farm land, or matters shown on a tax notice other than the property tax notice) or the Composite Assessment Review Board (residential property with 4 or more dwelling units or non-residential property).

All assessment complaints must be detailed and submitted in writing to the Municipal office on or before the final date of complaint as noted on the front of the 2020 Assessment and Property Tax Notice. The written complaint must include the correct fee as detailed below:

Assessment appeal fees will be returned if the Assessment Review Board makes a decision in favor of the residential complainant.

An assessment appeal does not exempt you from paying taxes on time or from late payment penal-

#### Can I appeal my taxes?

No. You can appeal only the assessment of your property.

#### What is a 'Tax Rate'?

A tax rate is the rate of taxation applied against the value of property within a municipality to collect the revenue required by the various taxation authorities. Normally the tax rate is expressed in mills (dollars in tax paid per thousand dollars of property value) or sometimes as a percentage of the property's value (i.e. a tax rate of 1.5% on a home valued at \$100,000 would require the payment of \$1,500 in annual property taxes).

### The municipal tax increase for 2020 is 2% or \$87,368.35.

Other increases include third party requisitions from the province for education, Pincher Creek Emergency Services for fire and ambulance services and the Pincher Creek Foundation for the Crestview Lodge.

In determining non-residential assessments, we may use any one of three approaches to value, depending on the type of non-residential property:

- Sales comparison approach—Sales of similar properties.
- Income approach—Capitalize the income being generated by property.
- Cost approach—Land value + the depreciated replacement cost of the property.

Whether you own a residential or non-residential property, and regardless of the approach used, the municipality must arrive at a market value assessment. Market value is recognized as the most understandable, transparent and objective measure of a property's worth. When a property is assessed every year, fluctuations in property taxes are minimized due to the more frequent reassessment process. Through the annual reassessment process, taxation responsibility is re-distributed from area to area, based on the extent to which values change relative to one another within the municipality

- Imposing meaningful deployment conditions across accelerated timelines to all spectrum holders.
   For example, a "use it or lose it" spectrum policy that requires greater rural deployment within five years of a license grant, where failure to build results in forfeiture of that license;
- Ending the use of spectrum set asides, particularly for rural areas, as set-aside eligible telecoms companies do not have a track record of deploying in rural Canada, and that spectrum goes unused; and
- 4. Continuing to invest in rural connectivity programs by launching the Universal Broadband Fund, supporting the CRTC Broadband Fund, and identifying opportunities to match or coordinate funding programs with the provinces.

We can no longer afford delays to the roll out of wireless connectivity. We hope that you will include rural connectivity as a key priority in the Speech from the Throne. We ask that these commitments be reflected in new ministerial mandate letters, reflecting your government's commitment to **encourage private sector investment in connectivity for [INSERT NAME OF MUNICIPALITY]**, and all of rural Canada.

#### **PURPOSE:**

For Council to review and respond to the proposed elimination of the Lethbridge EMS 911 dispatch of ambulance service center.

#### **RECOMMENDATION:**

That Council for the Town of Pincher Creek direct administration to draft a letter to Alberta Health Services requesting a postponement in closing the four municipal EMS 911 dispatch centers until all service delivery implications have been considered through consultation with municipalities.

#### **BACKGROUND/HISTORY:**

The Province recently announced that the four municipal EMS 911 Dispatch providers, (Calgary, Lethbridge, Red Deer and the Regional Municipality of Wood Buffalo) are being consolidated into a Provincial dispatch system. This endeavor has been considered before and it was found to have some significant coordination issues with the other emergency response services such as: police and fire response. These dispatch facilities are not included in the ambulance consolidation, consequently when emergency calls and situations that may require police and or fire come in, more time may be required to determine what service is needed and then communicate that call appropriately. This process involving more that one dispatch service will take time and could allow for human and technical error. In an emergent situation of course, time is of the essence. The other concern may be with the lack of familiarity of the regions where the emergencies occur and the lack of local knowledge from the centralized dispatch center. This too could result in a longer response time.

#### **ALTERNATIVES:**

That Council for the Town of Pincher Creek receive the information regarding the consolidation of all EMS 911 dispatch centers as presented.

#### **IMPLICATIONS/SUPPORT OF PAST STUDIES OR PLANS:**

This proposal has been considered and defeated previously.

#### FINANCIAL IMPLICATIONS:

AHS anticipates a more efficient and cost effective service with the proposed consolidation.

#### **PUBLIC RELATIONS IMPLICATIONS:**

This could have huge emergency response implications for the general public which could result in serious patient outcomes.

# EMS dispatch consolidation to benefit patients

August 4, 2020

CALGARY – Alberta Health Services (AHS) is announcing today that EMS 911 dispatch services will be consolidated across the province, further improving patient care and fiscal efficiency.

In alignment with a recommendation from the EY AHS Review, the EMS 911 calls handled by four municipally-run contracted satellite dispatch sites located in Calgary, Lethbridge, Red Deer and the Municipality of Wood Buffalo will be transitioned to one of three existing AHS EMS dispatch centres. These four municipally-run sites had remained separate from the AHS EMS provincial dispatch system established in 2009.

This transition affects EMS 911 dispatch services only; all local municipal fire, police and Medical First Response (MFR) will continue to be dispatched by the local municipalities.

"The adoption of this recommendation from the EY AHS Review is a further evolution of Alberta's promise to put patients first," said Tyler Shandro, Alberta's Minister of Health. "The provincial EMS dispatch system allows for better coordination of all EMS resources, including ground ambulances, and air resources, and reliable response times. EMS dispatch consolidation supports improved health integration and will facilitate broader health reforms."

This province-wide EMS dispatch system will improve patient care through more efficient coordination of all EMS resources, which allows EMS to send the nearest available ambulance to a patient regardless of geographic boundaries. EMS 911 dispatch also has the ability to involve realtime physician consultation on emergency calls to ensure patients get the highest quality care when they need it.

"The consolidation is the right decision for any Albertan needing emergency medical care," said Dr. Verna Yiu, AHS President and CEO. "This will improve care and ensure we are being fiscally responsible."

"This is about Albertans and providing the best care to 911 callers and patients. 911 callers will notice no change when they call for emergency help. By bringing all EMS services together, we are better able to maintain consistency and ensure sustainability of EMS dispatch services across all communities" said Darren Sandbeck, Chief Paramedic and Senior Provincial Director, AHS EMS.

While this consolidation is not primarily a financial decision, consolidation of the four municipal satellite dispatch centres will eliminate duplication and save over \$6 million annually.

The transition will take place over approximately six months, commencing August 4, 2020. When the transition is complete, EMS calls will be seamlessly transitioned from municipal call centres, to the AHS EMS provincial communications centres located in Peace River, Edmonton and Calgary. Callers to 911 will not notice any change.

To ensure resources are in place to meet increased call volume to the EMS Communications Centres, AHS EMS will hire 25 new Emergency Communications Officers (ECOs). Current municipal employees will be encouraged to apply for these roles.

Alberta Health Services is the provincial health authority responsible for planning and delivering health supports and services for more than four million adults and children living in Alberta. Its mission is to provide a patient-focused, quality health system that is accessible and sustainable for all Albertans.

Good evening Mayors, Councillors and CAOs,

Below is our statement that we released today regarding AHS changes to municipal 911 dispatch.

# AUMA statement on AHS changes to municipal 911 dispatch

Earlier this week, Alberta Health Services <u>announced</u> that EMS 911 dispatch services will be consolidated across the province, taking away dispatch centres operated by four AUMA member municipalities: Calgary, Lethbridge, Red Deer, and the Regional Municipality of Wood Buffalo. These four municipally-run EMS dispatch sites have provided reliable, efficient EMS dispatch services for decades, with response times at or below provincial benchmarks.

We share the Government of Alberta's commitment to the delivery of effective, efficient, and accessible EMS services for Albertans, but two aspects of this sudden announcement are concerning.

#### 1) We need more information about the impact of consolidation on response times.

While we understand a move toward efficiency, we have not seen data to indicate that response times will not be negatively impacted. Monetary savings should not be the main driver of this decision. A delay in response times, even of a few seconds, will cost lives and erode trust in the system.

#### 2) We are frustrated by the lack of consultation.

We are extremely disappointed with the lack of consultation both by the provincial government in making this announcement and their consultant, Ernst & Young, who failed to consult with municipalities during their comprehensive review process. Due to a lack of consultation in 2007, the first time ambulance dispatch was consolidated, significant issues arose. The transition had to be paused, which resulted in ambulance service delays and project cost overruns. Municipal engagement and consultation are critical to ensuring that changes to provincial policies and programs are successfully implemented.

This announcement caught us, and our four impacted member municipalities, by surprise. Substantive changes should not occur in a vacuum or without consulting stakeholders. The mayors of Calgary, Red Deer, Lethbridge and Regional Municipality of Wood Buffalo made every effort to communicate with the provincial government, as they outlined in their media conference on August 5 (view <u>part 1</u>, <u>part 2</u>, and <u>part 3</u>). It is unfortunate that these collaborative efforts were not returned by the Government of Alberta.

Albertans will measure the success of this change not by the dollars saved, but by any changes to EMS services and response times. We urge the Minister of Health to rethink this decision and keep EMS dispatch located in the communities.

We wish to work with the Government of Alberta to provide the most efficient and effective system of EMS response that best serves those in need and saves lives. As we stated last month, a real commitment by the provincial government to collaborate with AUMA and its membership is the only way forward to rebuild the prosperity of our communities and our province.

#### MFR Agency Coordinators:

Following a recommendation of the Ernst and Young Alberta Health Services (AHS) Review, AHS EMS will be moving forward with plans to consolidate 911 EMS dispatch services.

Four municipally-run satellite sites, Calgary, Lethbridge, Red Deer and the Municipality of Wood Buffalo, will be consolidated into one of the three AHS EMS dispatch sites: the Northern Communications Centre (NCC, in Peace River) and the Southern Communications Centre (SCC, in Calgary) and Central Communications Centre (CCC, in Edmonton). Termination for all four sites requires 180 days' notice. Notice was given today.

Patient safety is at the core of every decision AHS makes. This includes our approach to dispatching of EMS services across Alberta. The Ernst and Young recommendation validates earlier reports, including one by the Health Quality Council of Alberta, supporting dispatch consolidation for improved patient care and health integration. Consolidation of the four satellite dispatch centres will save over \$6 million annually. This is a fiscally responsible transition that will maintain patient safety and ensure consistency and sustainability of dispatch services across all communities.

A province-wide EMS dispatch system is more efficient and allows better coordination of all resources, allowing EMS to send the nearest available ambulance to a patient regardless of any geographic boundaries. 911 callers will notice absolutely no change.

We look forward to continued collaboration with our municipal partners and the Government as we phase in this transition.

- All existing workflows, business rules and response plans will be maintained
- MFR Agencies will continue to be notified of medical emergencies by their designated MFR Dispatch Centre as they are today
- This transition will occur over the next six months and should be seamless to your everyday work as an MFR provider
- Work from Wood Buffalo will transition to the Northern Communications Centre
- Work from Lethbridge, Red Deer and Calgary 911 will transition to the Southern Communications Centre

Today AHS gave notice to the municipalities of Wood Buffalo, Red Deer, Calgary and Lethbridge notice to terminate the agreements for EMS satellite Dispatch centers. This decision was made to ensure the best possible patient care and consideration of the Ernst & Young recommendation #34. Consolidating dispatch centers for EMS ensures a safer and more reliable borderless system that will benefit patients by improving medical oversight and continuity provincially. This decision is also fiscally responsible and will result in savings to the healthcare system.

Transition work to AHS dispatch centers will be occurring over the next six months and should be completed by early 2021. Please take note of the following:

- Work from Wood Buffalo will transition to the Northern Communications Centre (NCC).
- Work from Lethbridge, Red Deer and Calgary 911 will transition to the Southern Communications Centre (SCC).
- All System Status Management (SSM) plans and existing technologies will be maintained.
- Patients and front line workers will not notice any change as a result of consolidation.
